There is a huge and ever-expanding scholarly literature about Shakespeare and his culture. This general list and the ten-item lists accompanying the individual plays and poems in this volume are only a small sampling of the available resources. Journals devoted to Shakespeare studies include *Shakespeare Bulletin*, *Shakespeare Jahrbuch* (Germany), *Shakespeare Quarterly*, *Shakespeare Studies*, and *Shakespeare Survey* (England); other journals, such as *English Literary History*, *English Literary Renaissance*, *Renaissance Quarterly*, *Representations*, or *Studies in English Literature* also frequently publish essays on Shakespeare's works. The categories below are only approximate; many of the texts could properly belong in more than one category.
